- Obtain a Certificate of Good Standing from the presiding judge, clerk, or authorized official of the highest court of the State, Commonwealth, Territory or Possession, or of the District of Columbia in which you are admitted. The Certificate should evidence the fact that the applicant has been admitted as a member of the Bar of such court for at least three years.

## VABANC Launches First Ever Year-Long Fellowship to Provide Legal Services

SAN JOSE, California.

The Vietnamese American Bar Association of Northern California (VABANC) proudly announces the establishment of the *Lan and Mark Beyster Fellowship Program*, a post-graduate fellowship to be provided to a recent law school graduate. *The Lan & Mark Beyster Fellowship Program* will provide \$25,000 to enable a law school graduate to provide legal services to and advocacy for the Vietnamese American community and/or other underserved/underresourced communities.

"This is the first fellowship of this kind given by any minority bar organization in the country," noted Quyên Ta, President of the VABANC. "We are very excited by the program. This fellowship builds upon the work VABANC has done to encourage public service," said Ms. Ta.

This fellowship will be the *largest* fellowship amount offered by a minority bar organization to encourage and provide legal services and *pro bono* work with the Vietnamese American Community. Most Vietnamese Americans came to the United States as refugees. Despite some instances of model-minority accomplishments, many Vietnamese Americans still live in poverty and lack access to the legal system.

For the last 8 years, VABANC has provided two to three scholarships per year to law students to recognize their achievements and commitments to serving their communities and to encourage public service. *The Lan and Mark Beyster Fellowship* builds on VABANC's goals by supporting a recent law graduate who will serve the greater community and whose work will achieve a richer and more inclusive vision of social justice in underserved communities.

For many years, Mrs. Lan Beyster, Mr. Mark Beyster and their family have generously contributed to many philanthropic and educational endeavors. With this fellowship, the Beysters want to encourage public service in the Vietnamese American community and to provide low-income communities with legal services.

## The Lan and Mark Beyster Public Interest Fellowship

The Lan and Mark Beyster Public Interest Fellowship will provide \$25,000 to one law graduate who will work for one year to provide legal services to and advocacy for the Vietnamese American community and/or other underserved, underresourced communities. The Vietnamese American Bar Association of Northern California (VABANC) will administer the Fellowship Program.

The Lan and Mark Beyster Fellowship builds on VABANC's goals by supporting a recent law graduate who will serve the greater community and whose work will achieve a richer and more inclusive vision of social justice in underserved communities.

### Fellowship Requirements

Qualifications for applicants:

- J.D. in hand at the beginning of the grant period or awaiting bar results.
- Strong demonstrated interest and commitment in working with the Vietnamese American community and/or social justice work with underserved communities.
- Unique life experience or other experiences in overcoming personal adversity/challenges.
- Overall academic excellence.

1. Official Law School Transcript
2. Two letters of recommendation
3. Resume
4. A proposal no more than 3 pages (12 point, Times New Roman, 1 inch margins) detailing the proposed public interest project, and describing which legal rights the applicant will be enforcing and the project's relevancy in advancing the legal and civil rights of the Vietnamese American community and/or other underserved communities.<sup>1</sup>

# THE JUDICIAL INTERN OPPORTUNITY PROGRAM

## **APPLICATIONS BEING ACCEPTED!**

The ABA Section of Litigation will begin accepting applications for its Summer 2011 **Judicial Intern Opportunity Program** on October 4, 2010 for second-year law students and December 1, 2010 for first-year students. The program places minority or economically disadvantaged students with state and federal judges for summer internships.

The American Bar Association Section of Litigation will begin accepting applications for its Summer 2011 Judicial Intern Opportunity Program on October 4th for second-year law students. Applications for first-year law students will be accepted December 1st, in accordance with NALP guidelines. The program is a full-time (32 hours per week), six-week *minimum*, summer internship program open to all first- or second-year minority and/or economically disadvantaged law students.

The mission of the Judicial Intern Opportunity Program is to provide opportunities to students who are members of racial and ethnic groups that are traditionally underrepresented in the profession. The program also provides opportunities to students with disabilities, students who are economically disadvantaged and students who identify themselves as LGBT. Students may indicate geographic location preferences on their applications, but may not request particular judges or courts. Interns will receive an award of \$1,500.

Internships for students with an Intellectual Property Law focus will be offered in Chicago, Los Angeles, Texas and Washington, DC. Students can indicate their interest on their application. These specialized spots are limited and any student applying to the program with a request for specialization will also be considered for general litigation internships.

Applications should be submitted by January 7, 2011. Screening interviews will be used to better determine student qualifications. Screening interviews will begin in November and will continue through the application process. Interviews will be scheduled as soon as possible following the processing of applications. We will make every attempt to interview students where they attend school and in person. Students will be contacted by their assigned screener to set up the interview.
