Please write an essay on the following (attach as a separate document along with your completed application form): Explain why you would like to participate in the Women's Law and Public Policy Fellowship Program, and how both your personal career goals, as well as the cause of women's rights, would be advanced through your participation in WLPPFP. Feel free to include any information about your background or experiences, as well as your future plans, that you would like to be considered in your application to WLPPFP. In addition, WLPPFP may offer some Fellowships focusing on particular issues (for example, the Rita Charmatz Davidson Fellowship focusing on low-income women, the Harriet B. Burg Fellowship focusing on women with disabilities, Fellowships focusing on HIV/AIDS, international women's human rights, etc.). Please indicate in your essay whether you are interested in focusing on a particular issue(s) and if so, why. Expressing an interest in specific issues does not preclude an applicant from being considered for other Fellowships (unless you indicate a preference not to work on a particular issue).
- 17. The Georgetown University Law Center Domestic Violence Teaching Fellowship is a two-year position leading to an LL.M. degree that will be awarded to an applicant with experience litigating domestic violence cases. For additional details, please visit the clinic website at www.law.georgetown.edu/elinics/sdc. If you are interested in applying for the Domestic Violence Teaching Fellowship, please attach a supplemental essay describing any litigation, policy, or scholarship experience you have had in the domestic violence field. If you are interested in applying for the Domestic Violence Teaching Fellowship ONLY, please indicate this preference; otherwise, applicants will be considered for all Fellowships. Applicants for the Teaching Fellowship must have taken a bar exam prior to applying and must receive sufficient bar results by December 2007 in order to permit waiver into the DC Bar. Current students are not eligible.
- 18. WLPPFP may be able to offer a limited number of Fellowships to public interest lawyers focusing on women's rights who have already obtained positions working with public interest organizations in the Washington, DC area. These Fellowships would provide the opportunity to participate in all WLPPFP seminars, professional development training and networking events, but would not provide funding for the Fellow's stipend or salary. If you are interested in this type of Fellowship, please indicate the name of your employer, the date on which you started (or will start), the type of work that you are (or will be) doing in this position (e.g., impact litigation, public policy advocacy, direct legal services, etc.), and the substantive women's rights issues on which you will be focusing. Applicants for these Fellowships do not need to answer the question below concerning placement organizations. Please note: If you apply to WLPPFP through the regular application process, and later obtain employment with a public interest organization and would still like to participate in WLPPFP, please inform us as soon as possible.
- 19. Placement organizations and the types of work that Fellows perform vary widely. Please provide any information that may assist the Program in determining your placement organization in the event that you are selected as a Fellow, such as the type of legal work you would prefer (e.g. direct legal service, public policy advocacy, and/or impact litigation).
- 20. Please provide your current resume, indicating your employment history; your education (including participation in any extracurricular activities, clinics, law journals, most court competitions, etc.); any published materials or other significant original research papers; any special honors, awards, scholarships, or fellowships; and memberships in organizations or community activities in which you have been involved, including any leadership roles.
- 21. Please provide two letters of recommendation, as well as each recommender's contact information, including name, address, telephone number, and a brief explanation of each recommender's knowledge of your academic and/or work performance.
- 22. Please provide your official law school transcript. WLPPFP cannot consider your application until your official (stamped/sealed) law school transcript is received (photocopies are not sufficient). Please include an explanation of the grading and ranking system.

Send your completed application via e-mail to wlippf@law.georgetown.edu by Monday, November 1, 2010. Your recommendation letters may be scanned and sent as e-mail attachments, or may be mailed separately. Your official law school transcript (stamped/sealed) must be sent as a hardcopy. If you applied to WLPPFP last year, you do not need to resend your transcript or recommendation letters, but you must resubmit your completed application form with your responses to the questions (including your updated resume).
