Due to the Dumda building construction project and the increased numbers of children that we will serve, we are growing and expanding our fundraising strategies as well. This is our second year of asking for corporate sponsorships because our needs have surpassed what we can do within our individual donor donations. Our goal is to raise over \$200,000 this year.

We are planning an exciting year ahead with three fundraising events in the Houston area! We will have our First Annual Golf Tournament at the Houstonian Golf and Country Club on June 25<sup>th</sup>, our Gala at the Marriott Sugar Land Town Center on September 7<sup>th</sup>, and finally the Annual Children's Hope event to be scheduled in December 2012.
