Asian Wills Clinic Saturday, June 14, 2014

Asian Will Clinic Press Release:

Houston Volunteer Lawyers Program(HVLPP), VN TeamWork (VNTW), the Asian American Bar Association of Houston (AABA), and Boat People SOS (BP SOS) will co-host an Asian Wills Clinic on Saturday, June 14, 2014, to assist qualifying applicants in preparing and executing the following estate and incapacity planning documents: Will, Medical Power of Attorney, Directive to Physicians, HIPAA Release, and Declaration of Guardianship. Applicants who are potentially eligible for this program are encouraged to call VN TeamWork and ask for Nhi or Judy at (281) 495-8936 to set up an appointment. The clinic will be held on Saturday, June 14, 2014 from 9:00 AM to 1:00 PM (The last available appointment time slots will be 12:00 PM) at the VN TeamWork Center located at 11210 Bellaire Blvd., Houston, TX 77072.

General Outline and Instructions for the Wills Clinic:

Initial Intake and Questionnaires for Applicants:

- 1. Applicants must contact VN TeamWork as soon as possible to set up an appointment with VN TeamWork for intake and to fill out an estate planning questionnaire.
- 2. VN TeamWork will assist the applicant in filling out the Estate Planning Questionnaire. Questionnaires will include both English and Vietnamese translations of each question, but *answers* must be filled out in *English*. VN TeamWork will also provide a translator if needed.
- 3. Applicants will be given an appointment for a time slot between 9:00 AM and 1:00 PM. (11:00 AM 12:00 PM reserved for lunch) There will be up to 10-13 appointment time slots every hour, between 9:00 AM and 1:00 PM, totaling approximately 30-40 applicants. *Applicants will be reminded to show up at least 30 minutes before their appointment time* on the day of the Asian Wills Clinic (June 14th).
- 4. VN TeamWork should return the completed questionnaires to HVLP by Monday, April 28, 2014.
- 5. HVLP will process applications, verify eligibility, and prepare client folders containing completed estate planning questionnaires and HVLP case disposition forms for distribution to volunteer attorneys during the Wills Training Clinic (April 30th).

Wills Training Clinic for Volunteer Attorneys: (Wednesday, April 30, 2014)

- 1. Ideally, all questionnaires will be distributed to volunteer attorneys on **Wednesday**, **April 30**, **2014**, during the *Wills Training Clinic*, conducted by Peter Bennett at the law offices of Porter Hedges LLP from 11:30 AM 1:00 PM.
- 2. The remaining questionnaires will be distributed to AABA volunteer attorneys via email. All questionnaires will be assigned to volunteer attorneys no later than **Thursday**, **May 22, 2014**. Each questionnaire will also include the client's scheduled time slot for document execution during the Asian Wills Clinic.
- 3. The following six documents will be offered at this year's Wills Clinic: Will, Medical Power of Attorney, Statutory Durable Power of Attorney, Directive to Physicians, HIPAA Release, and Declaration of Guardianship. If an applicant requests any document not provided, please direct the applicant to HVLP for further legal services.

- 4. Volunteer attorneys will receive an Estate Planning Questionnaire filled out by applicants detailing their wishes as well as sample Estate/Incapacity Planning Documents to guide them through the drafting process. Documents should be drafted as accurately as possible with the information provided in the Estate Planning Questionnaire. Client interaction and interviews will not be necessary unless attorney feels comfortable speaking Vietnamese. Of course, not all applicants will want all six above-mentioned documents.
- 5. HVLP will also provide a packet containing sample estate planning forms to assist volunteer attorneys in drafting documents for their respective clients.
- 6. Volunteer attorneys should have all documents drafted and completed by **Thursday**, **June 5, 2014**. Volunteer attorneys should email copies of drafted documents to Tyrone.Lin@HVLP.org or Christine.Truong@HVLP.org for review.

Asian Wills Clinic: (Saturday, June 14, 2014)

Volunteer Attorney Responsibilities:

- 1. On the day of the Asian Wills Clinic, **Saturday**, **June 14**, **2014**, Volunteer attorneys should bring both a hard copy of their client's drafted documents (if no changes are necessary) to place in the client's folder and a saved copy of the duments on a flash drive.
- 2. Volunteer attorneys should ideally arrive an hour before their assigned client(s)' respective time slots. (Volunteer attorneys with 9:00AM appointments may arrive at 8:30 AM.) If assigned volunteer attorney cannot attend, then another volunteer attorney will fill in to review and execute documents (please let Tyrone or Christine know well in advance if cannot attend).
- 3. Upon arrival, volunteer attorneys should sign-in on a sheet at the intake table, make a name tag with their first name only, and then go to their assigned computer station.
- 4. Applicants will be escorted to their volunteer attorneys at their assigned computer station to review the drafted documents. If *no changes are needed*, the volunteer attorney will simply execute their client's documents at a designated Execution Ceremony Table. If *changes are needed*, the volunteer attorney may make the necessary changes at their assigned computer station and reprint the documents on printers provided by VN TeamWork, then proceed to the Execution Ceremony Table. (Printers and computers may become backlogged so, ideally, all documents should be completed and ready to execute before the clinic.)
- 5. There will be five Execution Ceremony Tables, with two witnesses and a notary provided at each table. If possible, the assigned volunteer attorney should help facilitate the Execution Ceremony with the provided Will Ceremony Execution Script, which will be available at each execution table.
- 6. After the Execution Ceremony, volunteer attorneys will make two copies of the executed documents for HVLP's client file at the provided copier station. While the copies are being made, volunteer attorneys should complete the HVLP case disposition form, if not already completed, and return the completed form to an HVLP staff member.
- 7. Volunteer attorneys should provide their client a copy of "Client Information about Documents" (available on the day of clinic), and be available to answer any client questions.
- 8. Before the end of each appointment Volunteer attorneys should ensure that the client is given both the original and one copy of the executed will, and the other copy to Tyrone Lin or Christine Truong.

Community Organization Grant Guidelines 2014

The Asian American Bar Foundation of Houston, Inc. seeks to award up to 2 community organization grants to Texas-based charitable non-profit 501(c)(3) organizations whose pursuits will impact the Greater Houston Metropolitan Area by (1) expanding the scope of legal services available to the Asian American community; (2) increasing the number of Asian Americans working as lawyers or in legal services; (3) educating members of the Asian American community of their civil and legal rights; (4) stimulating legal discourse by and/or about Asian Americans, the Asian American cultures and Asian American communities; or (5) otherwise promoting the interests of Asian Americans.

The 2014 AABF Community Organization Grant is a grant of up to \$5,000 to a charitable non-profit 501(c)(3) organization that fulfills the aims described in the preceding paragraph. The foregoing criteria may be weighed in any order as determined by the AABF. Applicant organizations must be charitable non-profit 501(c)(3) organizations incorporated or formed under the laws of the State of Texas and/or otherwise demonstrate a substantial connection to the greater Houston metropolitan area. Applicant organizations should submit application packages containing the following information to the Scholarship/Grant Committee:

- 1. Name of applicant organization
- 2. Contact information (name, address, telephone number, e-mail address) of applicant organization and representative of applicant organization
- 3. Proof of 501(c)(3) status of the organization
- 4. Copy of the mission statement (or, if no official mission statement exists, a statement of the primary purpose) of the applicant organization and information and materials about the applicant organization sufficient for the Scholarship/Grant Committee to understand the purpose of and activities conducted by the applicant organization
- 5. Information regarding a few recent events held by the applicant organization, if any
- 6. Description of and information relating to the program or event for which the grant funds are to be applied (the more detail, the better). Please keep in mind that the AABF cannot fund programs or activities that are not in keeping with its mission; therefore, program and activity descriptions should be detailed enough for the AABF to discern whether it is within the AABF's mission or guidelines.



- 7. Any other information that applicant organization desires to provide to assist in the application process
- 8. Cover letter stating how a community organization grant will help the applicant organization to achieve AABF's purposes listed above and serve the public interest

The grant recipient will receive an award of up to \$5,000 and a ticket for one of its representatives to attend the Asian American Bar Association of Houston's annual gala, to be held sometime in the late Summer or early Fall 2014, where the grant will be presented. The grant recipient is required to submit a final report no later than thirty (30) days after completion of the program or event that is supported by the grant funds explaining how the grant funds were used and the results of the program or event. Failure to provide the report may jeopardize future grants to the recipient organization.

Applicant organizations are advised to use these application guidelines as a reference and checklist to ensure that all necessary information is provided with the original application package. The AABF Scholarship/Grant Committee may contact applicants if additional information is required, but the Scholarship/Grant Committee reserves the right to disqualify application packages from consideration if key information is not included. The AABF reserves the right to subdivide the grants or increase the number of grants in its sole discretion.

2014 AABF Honorable Herbert W. Gee Memorial Scholarship Application Guidelines 2014

The Asian American Bar Foundation of Houston, Inc. seeks to award a \$2,000 scholarship in honor of the late Judge Herbert W. Gee, who was Associate Presiding Judge for the City of Houston Municipal Courts, a founding member and Past President of the Asian American Bar Association, and a recipient of the 2010 AABA Impact Award. The 2014 AABF Honorable Herbert W. Gee Memorial Scholarship will be awarded to an individual applicant who best embodies the spirit of the late Judge Gee who (1) was dedicated to serving the public, (2) supported the Asian American community in the greater Houston area, and (3) exemplified intelligence, generosity and leadership in his everyday life. The foregoing criteria may be weighed in any order as determined by the AABF.

To be eligible, an applicant must be (1) a member of the AABA, (2) enrolled in an ABA-accredited law school in Texas, and (3) intend to reside and seek employment in the greater Houston metropolitan area after graduation. Applicants should submit application packages containing the following information to the Scholarship/Grant Committee, where applicable:

- 2. Contact information (name, address, telephone number, e-mail address)
- 3. Name of school
- 4. School address and contact information for registrar's office
- 5. Degree sought
- 6. Expected graduation date
- 7. Copy of transcript, GPA and class rank (if available) or other proof of enrollment at an ABA-accredited law school in Texas

- 9. Course work, clinics or other relevant extracurricular activities at current or previous schools relevant to AABF's purposes listed above
- 10. Employment history (if any)
- 11. Employment experience relevant to the criteria listed above
- 12. Community and volunteer experience relevant to criteria listed above
- 13. Involvement with Asian American community relevant to criteria listed above



- 14. Leadership experience relevant to criteria listed above
- 15. Independent research or publications relevant to criteria listed above
- 16. Awards, honors, scholarships received
- 17. Other activities, hobbies, skills, positions held in any organizations, etc.
- 18. Any other information that applicant desires to provide to assist in the application process
- 19. Cover letter stating how the applicant demonstrates or embodies the criteria set forth above

The scholarship recipient will receive a \$2,000 scholarship to help cover tuition and academic expenses and 1 ticket to the Asian American Bar Association of Houston's annual gala, to be held sometime late Summer or Fall 2014, where the scholarship will be presented. The scholarship recipient is required to submit a final report at the following year updating the AABF on the status of the recipient's studies and activities and how the scholarship has helped the recipient.

Scholarship applicants are advised to use these application guidelines as a reference and checklist to ensure that all necessary information is provided with the original application package. The AABF Scholarship/Grant Committee may contact applicants if additional information is required, but the Scholarship/Grant Committee reserves the right to disqualify application packages from consideration if key information is not included. The AABF reserves the right to subdivide the scholarship or increase the number of scholarships in its sole discretion.

AABF Pro Bono Scholarship Summer 2014 or Fall 2014 Scholarship Application Guidelines

The Asian American Bar Foundation of Houston, Inc. (the "AABF") seeks to award one scholarship to an individual (the "Recipient") who will further their legal education and training while primarily being exposed to the pro bono programs and legal practice at Houston Volunteer Lawyers ("HVL") which generally "educate and serve Asian American lawyers and communities in the greater Houston and surrounding areas" in accordance with the mission of the AABF. The Recipient's education and training will be supervised by HVL, mainly under the direction of Tyrone Lin and Alissa Rubin Gomez, in a manner that serves the foregoing primary purpose.

The Recipient is expected to further his/her legal education and training during a ten week period (which may occur, at the Recipient's option, during the summer of 2014 or 2014 fall semester) to commence no earlier than June 1, 2014 and to end not later than December 15, 2014 at HVL. The Recipient is expected to devote his/her part-time efforts to further his/her legal education and training at HVL, equivalent to not less than 10 hours per week.

The Recipient will receive a \$3,000 award (payable in two equal installments on dates to be determined). The Recipient shall deliver a report to the AABF summarizing his/her scholarship activities and how the grant was used to further the Recipient's legal education and training. The award is to be used for the Recipient's law school tuition and fees, books, supplies, and equipment for law school courses.

The Recipient must be enrolled as a full time law student at an American Bar Association accredited law school. Preference shall first be given to those qualified full time law students enrolled at an ABA accredited law school in the greater Houston area.

All applications will be submitted to the AABF in care of Joyce Kao Soliman at the address below by not later than <u>May 27, 2014</u> via U.S. Certified Mail/Return Receipt Requested or by email in PDF format with reply confirmation that the application has been received.

- 14. Awards, honors, scholarships received
- 15. Other activities, hobbies, skills, positions held in any organizations, etc.
- 16. Any other information that applicant desires to provide to assist in the application process
- 17. Cover letter stating interest in the scholarship and proposed dates for serving the ten week period at HVL
- 18. Name and contact information of at least one work, professional or educational reference of the applicant (please do <u>not</u> provide more than three references)

Scholarship applicants are advised to use these application guidelines as a reference and checklist to ensure that all necessary information is provided with the original application package. The Scholarship Committee may contact applicants if additional information is required, but the Scholarship Committee reserves the right to disqualify application packages from consideration if key information is not included.
