Houston Lawyer Referral Service. The Houston Lawyer Referral Service wants to increase its Asian-American attorney membership, especially attorneys who speak Mandarin, Cantonese, or Vietnamese. The HLRS receives upwards of 120,000 calls for referrals every year and matches those requests with lawyers who practice in 38 categories of law, including family law, consumer law, commercial law, criminal law, immigration law, probate law, personal injury, real estate and property law. The Asian Pacific American Women's Leadership Institute ("APAWLI") is the only national, non-profit organization dedicated to enhancing and enriching leadership skills for Asian Pacific American women leaders. APAWLI's primary mission is to place ethical, caring, and compassionate Asian American and Pacific Islanders women at leadership tables by providing leadership training programs designed to assist Asian American and Pacific Islanders women acquire the tools and techniques to find their voice or passion and have their voices heard.

APAWLI 2004 Discovery Leadership - A Regional Leadership will be held in Houston. The Discovery Leadership Program is targeted toward women between 25-35 with 4-5 years experience who are already viewed by their communities as emerging in their capacity and talent to lead. The program will select 12-16 AA/PI women to spend a weekend for each month for five months with APAWLI faculty and staff. The program seeks to help women answer the questions, "Who am I?" and "So What?" and provide technical skills such as team building, public speaking, consensus-building and ethics and values clarification. Upon completion of the program, the women will collaboratively develop a community impact project that will benefit at least 25 individuals in their community.
