

#### 2008 Law School Summer Boot Camp for Students of Color

Everyone admitted to law school has demonstrated similar intelligence, commitment and effort. What distinguishes "A" students is study skills and habits, access to legal information, analytical and test-taking skills. All these are skills and abilities that can be learned and improved on. In our more than 35 years of experience of helping students-of-color succeed, we have seen the impact that intense preparation can have on a student's ability to excel. In a competitive environment like law school, where grades are given based on how a person performs compared to the other students in the class, it is essential the entering law students-of-color be appropriately prepared.

The Summer Boot Camp (<a href="http://www.thejdproject.org/Excelling/BootCamp/index.htm">http://www.thejdproject.org/Excelling/BootCamp/index.htm</a>) is an online distance learning program designed to provide that intense preparation. The Boot Camp teaches students to study effectively for law school, introduces students to the writing, thinking and test-taking skills needed to excel on law school exams, and builds a network of academic support that crosses school boundaries. The participants will work on the study skills, strategies and techniques they will need to achieve their goals as law students.

This is a 100 hour online program. It is \$600 (Compared to \$2000 for a 40 hour program by BarBri). Admission is on a rolling basis till the program is filled. Because of the intense nature of this program it is important that students start as early in the summer as possible, preferably by June 1st. #### The CUFE Law School Autumn Semester Program in Beijing, China

The CUFE Law School Autumn Semester Program in Beijing (the Program) operates in connection with a collaborative student exchange program with the University of Maryland School of Law and the Maastricht University Faculty of Law. Law students from around the world are eligible to study in Beijing in the fall semester with students from the CUFE Law School, the University of Maryland, and Maastricht University. The Program cultivates a diverse learning environment in which the different cultural and legal backgrounds of the students and faculty enrich the study of comparative law, and is one of the few academic programs in China in which visiting students study in the same classroom with Chinese students. All courses are conducted in English.

The Program begins with foundation courses on the Chinese Legal System and Comparative Law, offering students an unparalleled opportunity to learn the basics of Chinese law and comparative research methodology from CUFE's renowned faculty. Thereafter, the focus shifts to business law, with courses such as Select Topics in Chinese Commercial Law, Comparative Anti-Monopoly Law, Foreign Direct Investment in China, Comparative Commercial Law, Comparative Government Procurement Law, and even a Business Law Trial Competition. The specific courses offered in a particular year will depend on professor availability and student demand. On and off campus housing is available, and site visits to legal institutions and points of interest are incorporated into the program. Students may also study Mandarin Chinese as part of the program (subject to additional costs), and internships in Beijing may be available. It is recommended that students have at least one year of academic training in law before entering the program. Students who successfully complete the Program will receive a Certificate in Comparative Business Law from the CUFE Law School, Information on the program is also available at <a href="https://www.law.umaryland.edu/china">www.law.umaryland.edu/china</a>.

Each 2008 AABF Texas Bar Review Grant is a one-time grant in the amount of \$500. Grants will be given to the two student applicants selected by the AABF taking into account financial need, academic merit, program of studies and commitment to public service. The foregoing criteria may be weighed in any order as determined by the AABF, although priority may be given to the financial need criteria as the AABF may deem appropriate. Applicants must be residents of the greater Houston metropolitan area, be enrolled in an accredited law school in Texas, intend to reside and seek employment in the greater Houston metropolitan area after graduation, or otherwise demonstrate a substantial connection to the greater Houston metropolitan area. Applicants should submit application packages containing the following information to the Scholarship Committee:

Each grant recipient will receive a one time \$500 grant and a ticket to the Asian American Bar Association's annual gala, to be held September 26, 2008, where the grant will be awarded. The grant recipient is required to submit a final report at the conclusion of the 2008-2009 school updating the AABF on the status of the recipient's studies and activities.

The Asian American Bar Foundation of Houston, Inc., seeks to award scholarships to individuals whose scholarly pursuits will impact the Greater Houston Metropolitan Area by 1) expanding the scope of legal services available to the Asian American community; 2) increasing the number of Asian Americans working as lawyers or in legal services; 3) educating members of the Asian American community of their civil and legal rights; 4) stimulating legal discourse by and/or about Asian Americans, the Asian American cultures and Asian American communities; or 5) otherwise promoting the interests of Asian Americans.

The 2008 AABF Public Interest Scholarship is a \$1,500 one-year award to the student whose academic merit, program of studies and commitment to public service best fulfill these aims. Applicants must be residents of the greater Houston metropolitan area, be enrolled in an accredited law school in Texas, intend to reside and seek employment in the greater Houston metropolitan area after graduation, or otherwise demonstrate a substantial connection to the greater Houston metropolitan area. The scholarship recipient is required to submit a final report at the conclusion of the 2008-2009 school year explaining how the scholarship funds were used and updating the AABF on the status of the recipient's studies and activities.
