Asian Pacific Americans in Law Survey

Survey responses will help the students advocate for disaggregated data on Asian Pacific Americans in the legal profession. The study will analyze the unreliability of the umbrella categorization of “Asian American,” within AmLaw 200 firms, as a measure of success of all Asian American ethnic groups. The existing statistics of “Asian Americans” within big law firms do not accurately reflect the diversity within the practice as the statistics do not account for the disparity among different Asian Pacific American ethnic groups.
